

Author Guidelines

TYPES OF CONTRIBUTIONS

Pharmacy Education will consider the following types of communications:

Research papers connected to any field of pharmacy education and training. Research articles describe experimental or observational investigations that used formal methods for data collection and reporting of results of studies directly related to pharmacy education (maximum 8000 words).

Reviews are comprehensive, well-referenced descriptive papers on teaching or research topics directly related to entry-level, and graduate or postgraduate education and training or skills development (maximum 8000 words).

MANUSCRIPT ORGANISATION

All papers must be submitted in English and should be formatted double-spaced, with margins of at least 2.5 cm. Manuscripts should be divided into: Title page, Abstract, Introduction, Methods, Results, Discussion, References, Figures, Legends, and Tables. Please start each of these sections on a new page. All pages should be numbered. Each article should be accompanied by a summary (abstract) of 150 words on a separate page. All authors should provide their affiliation details together with e-mail addresses as requested during the Submission Process. For the Corresponding Author (CA) full postal address, including the telephone, fax and e-mail details of should be included.

Title Page

This should, in addition to the title, list full addresses for all authors and the name of the department and institution in which the work was carried out and be loaded onto the Submissions platform as a Supplementary Page

Abstract

Each paper requires an abstract that should not exceed 150 words.

Keywords

Three to six keywords should be listed below the abstract in alphabetical order, separated by commas.

Text

The text should be written in the 3rd person and be scholarly, readable, clear, and concise. Standard nomenclature should be used. Unfamiliar terms and acronyms should be defined at first mention. manuscripts that were prepared for oral presentation must be rewritten for print. Authors of research papers are discouraged from writing excessively long introduction or discussion sections.

Text Headings

Headings should be set over to the left-hand margin and the text should begin on the next line.

Illustrations

Illustrations should not be inserted into the text but provided on separate pages within the file. All illustrations and charts should be consecutively numbered (e.g. Figure 1). Any photographs should be included separately or scanned into a separate file and included with the manuscript file and be of publishable quality. All figures should have a caption to make interpretation possible without reference to the text. Captions should include keys to symbols. All illustrations should be in black/white/grey scale unless essential colour is required.

Figures

All figures should be numbered with consecutive Arabic numbers, have descriptive captions, and be mentioned in the text. Keep figures separate from the text but indicate an approximate position for insertion. All figures should be in Black/white/grey scale.

Tables

Tables should be inserted on separate pages within the file and should be consecutively numbered with Roman numerals. Indicate in the margin where tables should be inserted. Words or numerals should be repeated on successive lines: "ditto" or "do." should not be used. Each table should have a caption describing its contents. Footnotes to tables should be typed beneath it. Use symbols to refer to them.

References

Style, statistical reporting, and reference citations should conform to the American Psychological Association's guidelines, from the APA Publication Manual, seventh edition.

To conform with the APA Publication Manual, fifth edition, references should be alphabetised at the end of the manuscript text, in the following formats:

Please avoid excessive referencing. Only papers that have been published or are in press may be cited; abstracts, unpublished data and personal communications should not be included in the reference list but may be included in the text. Obtaining permission to quote personal communications and unpublished data from the cited author is the responsibility of the author.

Footnotes should be indicated in the text by the following symbols:

* (asterisk or star), † (a dagger), ‡ (double dagger), ¶ (paragraph mark), § (section mark). || (parallels), # (number sign). Do not use numerals for footnote callouts as they may be mistaken for bibliographic reference callouts or exponents. Type each footnote at the bottom of the typescript page on which its text call-out appears. Footnotes within a table should be indicated by the same symbols listed above. Reinitialise symbol sequence within tables. Type footnotes to a table directly beneath the table.
