AUTHOR COMMENTS: This paper does not present enough theoretical support, this should be improved. The paper should clearly state what features you used in the training and testing processes.

AUTHOR COMMENTS: The flow of the paper is proper and the author has explain the things properly. There is a need of improvement in discussion part as it should be more elaboartive and authors suggest some future suggestion regarding the validation of the approach.

AUTHOR COMMENTS: The paper needs major revision in terms of English language.

Grammar Issues:

- Paper contains numerous grammatical mistakes. Authors need to proofread article from any expert in English.
- Use past simple tense in to explain methodology.

Punctuation Issues:

- Various places need proper punctuation to make sentences easily readable.

Sentence Structure Issues:

- Several phrases and sentences are to be restructured. Such as this paragraph "In Indonesia there are several researches on music therapy to reduce depression score with local music, that is by keroncong music, as conducted by [11]–[13] as well as with traditional Javanese music [14], [15]." and "So far, no research on classifying mood perception computationally on local Indonesian music, especially keroncong music."
- "Previous research conducted research on music therapy to reduce symptoms of mild depression" to "Previous literature focused on music therapy to reduce symptoms of mild depression"
- "Intensity and tempo are gained by computing RMS" What is RMS?

General Issues:

- Enlarge Figure 3 and Figure 4 to page width. It is completely unreadable at the moment.
