Introduction:

There are many grammatical errors. This needs corrections.

Materials and methods:

The authors have mentioned temperature wrongly. The correct way is $90 \pm 2^\circ\text{C}$.

The butanol-acetic acid-water phase with a ratio of 4: 1: 5 (v/v)..... It should be 4: 1: 5 (v/v/v)

The centrifugation speed must be expressed in " × g" and not rpm

Replace minutes with min.

The statistical analysis statement is missing in the Materials and methods section

Results and Discussion:

Table 2: Express the results of wavelength and transmittance as mean \pm std deviation

Authors should incorporate UV-Vis spectra that shows maximum wavelength and transmittance in it as a separate figure.
